### **New Business:**

Donations – Club suggested doing an annual donation to an organization. Bob Heins is going to contact Carol Ruscoe at Elmore SPCA to see what time of items and/or monetary funds are they looking for people to donate.

Linda LaPier received an email from Pine Harbor in regards to a 4 month old lab they intend to keep at their facility and would someone go to the facility and give instructions to a staff member there on how they can teach the dog. It was suggested that Linda reach out to Pine Harbor and convey that a staff member may bring the dog to the puppy class at no charge. Motion made by Kim Bailey to not charge Pine Harbor in taking a class for their new puppy. Seconded by Helen Morales. All in favor, motion carried.

Membership – As of September 17, 2023, the Club's membership consisted of 55 individual memberships and 30 family memberships for a total of 85 regular memberships along with 10 individual provisional memberships and 7 family provisional memberships for a total of 17 provisional members. In June at the Club's meeting, the Provisional members were voted in as regular members increasing the Club's regular membership to 102. There have been 51 paid individual memberships renewed and 20 paid family membership renewed for a total of 71 paid regular memberships. 20 individual memberships and 11 family members have not renewed decreasing the Club's regular membership to 71.

Calendars (tabled from 11/9/22) - It was noted that September 2025 will be the Club's 40<sup>th</sup> anniversary. Linda LaPier will contact Vicki Siskavich to inquire about a committee to plan an event(s) for this celebration. Vicki had done the original research for the 25<sup>th</sup> anniversary plans that were unable to move ahead during the COVID-19 pandemic.

Charter Members –It was suggested that charter members be granted "lifetime membership". Vicki Siskavich will be contacted regarding knowledge of charter members.

Other – Kim Bailey would like to see term limits for Board Members.
